#### INTRODUCTION

- The Ministry of Environment, Forest and Climate Change
   (MoEF&CC) is implementing the UNEP/GEF supported Phase II
   Capacity Building Project on Biosafety, aimed at
   strengthening the biosafety management system in India to
   ensure adequate protection of human health and biodiversity
   from potential harm arising from activities involving living
   modified organisms (LMOs). The focus of the project is own
   LMOs in agriculture.
- The key thrust areas of the project are Risk Assessment and Risk Management, Handling, Transport, Packaging and Identification of LMOs, Socio-economic considerations and Public Awareness.
- The four thrust areas have been prioritized to be in line with the Strategic Plan of the Cartagena Protocol on Biosafety (CPB) for the period 2011-2020.




# Thrust Areas Prioritized in line with Strategic Action Plan of CPB (2011-2020)

- The outcomes under these thrust areas are intended to contribute to the overarching goal, i.e, to assist the Government of India to comply with the international obligations as Party to the CPB.
- Regional Networking and Cooperation is an integral part of the biosafety projects of UNEP/GEF towards promoting regional harmonization of biosafety regulations and standards for the effective implementation of national biosafety frameworks.
- During the course of the project, the project outcomes have been presented at regional and international platforms for sharing of information and experiences.

#### **REGIONAL EVENTS ORGANISED UNDER THE PROJECT**

Two Regional events were organised as part of the project for sharing of experiences among Asian Countries. Government officials and experts from 10 countries *viz.*, Bhutan, Cambodia, India, Lao PDR Malaysia, Mongolia, Philippines, Republic of Korea, Sri Lanka and Vietnam attended these event. Participants from India included members of regulatory committees, senior officers from various Ministries/Departments and scientists from partnering institutions/ organizations associated with implementation of the Phase II Capacity Building Project on Biosafety.

#### REGIONAL CONFERENCE ON STRENGTHENING THE BIOSAFETY CAPACITIES AND SHARING OF EXPERIENCES IN THE REGION

A Regional Conference on Strengthening the Biosafety Capacities and Sharing of Experience in the Region was organised on April 7-8, 2016 at Hyderabad for encouraging South-South cooperation in the area of biosafety. It was intended for sharing of experiences by the participating Asian countries towards harmonization of biosafety frameworks at regional level.

It covered an overview of existing status of biosafety framework of the participating Asian countries particularly with regard to their national policies on biosafety, relevant laws and regulations, biosafety administration systems, procedures for granting approval to LMO applications, current status on research, development and use of LMOs with a focus on challenges and key areas for capacity building in biosafety.











### REGIONAL WORKSHOP ON RISK COMMUNICATION

A Regional Workshop on Risk Communication was organised on April 4-6, 2016 at Hyderabad towards developing communication skills for addressing queries related to LMOs/GMOs, at various stages of regulatory process for different stakeholders from the Asian region.

It covered presentations on evolution of risk communication, practitioner foundation theories, trust determination, risk perception, message map development and how to fine tune the message maps and use risk communication principles in oral communications. Practical training on how to use message maps as a basis to respond to interviews was also discussed at the two day workshop.

## PARTICIPATION IN THE SOUTH ASIA BIOSAFETY CONFERENCE

- The South Asia Biosafety Conference (SABC) is an annual event organized under the aegis of South Asia Biosafety Program, an international developmental program being implemented in India and Bangladesh. It is coorganized by ILSI Research Foundation, USA and Biotech Consortium India Limited (BCIL), New Delhi with support from National Agencies/organizations.
- The annual event provides a platform for sharing of knowledge on current developments in the area of biotechnology, environmental risk assessment and biosafety regulation of genetically modified organisms in the South Asian region.
- More than 200 participants from about 15 countries participate in the conference annually, including senior officials from concerned Ministries and Departments dealing with agriculture biotechnology and biosafety issues; members/representatives of regulatory authorities/committees; scientists from public research institutions; representatives from the Indian private sector/industries and research students engaged in activities related to GE crops.
- MoEF&CC supported and actively participated in the 3<sup>rd</sup> and 4<sup>th</sup> annual SABC to share the outcomes of the Phase II Capacity Building Project on Biosafety. The project supported the participation of project partners, regulators and scientists.
- In the 3<sup>rd</sup> SABC held at Dhaka, Bangladesh the Biosafety Resource Kit and the Monitoring Manual on Confined Field Trials of Regulated GE Plants prepared as part of the project were released.
